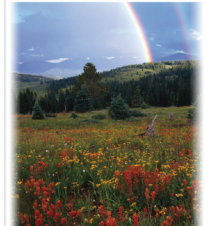

HEALTH, TOXICITY AND SAFETY

Oral toxicity: LD₅₀ > 5000 mg/kg of body weight
 Dermal toxicity: LD₅₀ > 1000 mg/kg of body weight
 Inhalation toxicity: LC₅₀ > 200 mg/L at 20 ppm
 Carcinogenicity: Products will not be accepted as a carcinogen or be listed by IARC, NTP, or CA Prop 65.

PROTECTION OF AQUATIC LIFE

Aquatic toxicity: L(E)C₅₀ > 1-10 ppm then biodegradation must occur within a 10 day window
 Aquatic toxicity: L(E)C₅₀ > 10-100 ppm then biodegradation must occur within a 28 day window
 Aquatic toxicity: L(E)C₅₀ > 100 ppm then biodegradation need not occur within 28 days if the product is of concern and half-life > 100 days.
 Note: If product is an aquatic toxicant, then it must biodegrade rapidly and not be bioaccumulative.
